
ACTIVITY SUBJECT:

To organize national and international artistic events, to participate in these fields, and to organize activities and events in the fields of painting, sculpture, ceramics, photography, film, graphics, music, and handicrafts with an artistic and scientific scope. To organize all kinds of promotional services, public relations activities, show programs in tourist facilities, animations, events, and entertainment programs, and to present such programs. To provide all kinds of animation services and to organize events. To arrange promotional services for businesses such as health institutions, stores, restaurants, or historical sites and to make commission agreements. To promote and market these services to domestic and foreign audiences or through third parties. To generate revenue through contracts specifying promotion fees or commission arrangements. To provide consultancy and support related to these activities. To organize and host various theater performances, seminars, congresses, commercial education for all business and sector groups, symposiums, meetings, exhibitions, openings, cocktails, invitations, parties, celebrations, competitions, weddings, concerts, and recitals, and to carry out or have carried out all necessary promotional and advertising activities. In connection with its field of activity, the business may carry out its own decoration work for cocktail parties, weddings, openings, animations, and entertainment events. It may rent, lease, transfer, acquire, construct, or purchase and sell, or operate accommodation and entertainment facilities such as hotels, motels, camping grounds, boarding houses, holiday villages, rest houses, thermal stations, beaches, pastry shops, restaurants, cafeterias, tea gardens, coffeehouses, hookah lounges, and comprehensive tourist facilities, including swimming pools, baths, saunas, tourist areas, parking lots, water sports, winter sports, nature sports, mountain tourism, thermal tourism, open and closed sports halls, nightclubs, mountain, sea, and other water sports and entertainment activities such as rafting, water skiing, swimming, and other related mountain and water sports, as well as the facilities and businesses necessary for these activities. In accordance with the Travel Agencies Law No. 1618, it may obtain an agency certificate, establish tourism agencies domestically and internationally, and accommodate local and foreign tourists by organizing tours. It may establish, operate, transfer, and acquire travel agencies in order to provide tourism services both domestically and abroad, establish and operate branches of previously established agencies, organize domestic and international tourism activities, arrange sightseeing tours, sell tickets for such tours organized by other travel agencies, and make and manage related reservations. It may also provide passenger transportation services by land, organize tours and guidance services, transportation and accommodation services, and related consultancy services. It may reserve, purchase, and sell tickets for land, sea, and air transportation vehicles. It may meet the needs of local and foreign yachts of all kinds, and ensure these needs are met by coordinating with other businesses. To rent and lease bicycles, motorcycles, and cars related to tourism. To carry out or have others carry out land transportation and transfer services necessary for providing tourism services domestically and internationally. To organize national and international artistic events, and participate in such activities, organizing artistic and scientific events and activities, including painting, sculpture, ceramics, photography, film, graphic arts, music, and handicrafts. To organize show programs, animation, events, and entertainment programs in tourist facilities and present these programs. To purchase, sell, import, export, and lease mountain tourism, plateau tourism, and land and air sports equipment and vehicles. To engage in all kinds of nature, underwater, and surface water sports activities, to purchase equipment related to underwater diving and surface water sports, and to handle the usage, purchase, sale, import, and export of all kinds of tools, equipment, and materials required by these activities.
